I do hereby release, forever discharge and agree to hold harmless Help Us Save Us, Inc., its directors and its employees thereof from any and all liability, claims or demands for personal injury, sickness or death, as well as any property damage and expenses, of any nature whatsoever which may be incurred by the undersigned and the participant that occur while said person is participating in work or recreational activities in Haiti with Help Us Save Us, Inc.

The undersigned further agrees to hold harmless and indemnify said Help Us Save Us, Inc., its directors, employees and agents for any liability sustained by said acts of said participants, including any expenses incurred attendant thereto.

I understand that if I engage in activities, which adversely affect the testimony and moral standards of Help Us Save Us, Inc. I will be subject to immediate dismissal

from participation with them and will be responsible to make alternate lodging and transportation arrangements, at my own expense.

I am aware of the recommendations of Help Us Save Us, Inc. regarding seeking a physician's approval of good health appropriate for travel to Haiti, Tetanus shots/boosters, Hepatitis A vaccinations, Hepatitis B vaccinations and preventative medications for Typhoid and Malaria. The undersigned acknowledges personal responsibility to choose whether to follow these recommendations and agrees to hold harmless and indemnify Help Us Save Us, Inc. in the event of the development of any disease or any other health problems incurred by the subject of this release while in Haiti.
